### Boerne ISD's ESSER III Allocation



ARP ESSER III funding intent and purpose

- help safely reopen
- sustain safe school operation
- address impact of the coronavirus pandemic on students



Final allocation: \$4,149, 379

Allowable expenditures are those related to preventing, preparing for, and responding to the COVID-19 pandemic





## First Priority: Learning Loss

Expenditures to address learning loss must exceed 20% of the total grant funds.

BISD's plan is to spend 51% of the total allocation on learning loss.



#### **Class Size Reductions**

- Additional teachers in Grade 1
- Additional teachers in other high enrollment elementary grades



Implementation of Middle School Instructional Coaches in 2021-2022 and High School Instructional Coaches in 23-24



**Bilingual Coaches/Interventionists** to address Emerging Bilingual student learning loss



**Expanded Summer School** opportunities to address student learning loss in summers 2022, 2023, 2024 to include learning opportunities for economically disadvantaged and at-risk students.



Provide high quality professional development and
 other services focusing on evidence-based activities to meet the comprehensive needs of students



Allow for continuity of educational services by continuing to employ existing teachers



Address student learning, student learning loss, and increasing student proficiency in technology by adding interactive whiteboards into classrooms





### Other Planned Uses of Funds

#### Prevention and Mitigation Strategy



#### Employ a COVID-19 Administrator to:

- oversee/coordinate district safety protocols (SY21-22, only)
- align district practices to state and local health guidelines
- provide continued parent and staff notifications of confirmed COVID-19 cases within a classroom or workspace
- stay abreast of <u>CDC</u> and <u>State</u> mandates, recommendations, and guidelines.

#### **Student Social Emotional Learning**



Combine ESSER and Title IV grant funds to provide for the continued use of the **Devereaux Student Strength Assessment** (DESSA) to:

- assess a student's social emotional learning skills
- enable school staff to design an intervention plans for students who need additional instruction in a particular skill
- assess risk and provide intervention for students at risk of violence



## Methodology

**Executive leadership**, though consideration of public input, financial data, and consultation with the Board of trustees, came to consensus that student learning loss was the priority for the use of funds. Maintaining lower student/teacher ratios was the primary selected strategy.



BISD reviewed student performance data and stakeholder input through the District Education Improvement Committee (DEIC) meetings in April 2021 and May 2021.

The DEIC is comprised of representative stakeholders including teachers, administrators, district leadership, paraprofessional staff, parents, business and community members, and students.

The proposed use of funds was presented to the Board of Trustees in <u>June 2021</u> and was made available for public comment.



A review of the Use of Funds Plan was conducted with stakeholders in the DEIC meetings in <u>February 2022</u> and <u>April 2022</u>. Subsequent reviews are scheduled for October 2022, April 2023, October 2023, and April 2024. Meeting agendas and presentation information can be located here DEIC.

## Summary



#### The strategy will be implemented by

- continuing to employ current teachers to provide continuity of services
- hiring supplementary teachers at the elementary level to reduce class size, with Grade 1 being targeted first
- hiring instructional coaches at the middle schools, including bilingual instructional coaches, to address learning loss through increasing teacher effectiveness



### Additionally, LEA prioritized the use of grant funds to continue

- implementing strategies/tools that address the Social Emotional Learning of students
- addressing student/staff COVID-19 safety protocols by the ESSER-funded COVID-19 Administrator
- Incorporating technology in the classroom to address student learning, student learning loss needs, and proficiency in the use of technology
